General Conditions of Participation for the Summer Courses of the Westfälische Wilhelms-Universität Münster

1. Coverage

These general conditions of participation govern details of the participation in the summer courses "Mergers and Acquisitions" and "International Taxation" offered by the Westfälischen Wilhelms-Universität in cooperation with JurGrad gGmbH (nonprofit LLC) in connection with the registration form.

2. Registration

2.1 The application form is to be completed by filling in the required information.

2.2. With remittance of the application form, the applicant explicitly accepts the general conditions of participation.

2.3. Accessory agreements must be in written form in order to be effective. Unilateral reservations or conditions do not become subject of contract. This applies also to deviation from requirement of written form.

2.4. JurGrad gGmbH decides upon the number of course participants.

2.5. Contract becomes valid with confirmation of registration. In case of non-admission, the contract becomes void (disbanding condition). Payment is to be effected to JurGrad gGmbH, account number 389 528, Sparkasse Münsterland Ost, bank code number 400 501 50 by the date specified on the respective application form. Payment is considered as received when it is credited to the account of JurGrad gGmbH.

3. Scope of Service

The scope of the service of the summer courses result from the course brochures, the schedule as well as from details specified in the respective application form.

4. Change of Service

4.1 JurGrad gGmbH reserves the right to cancel or modify the courses due to organizational or other reasons under the conditions mentioned beneath:

4.2 Cancellation can only take place when it is in the legitimate interest on the part of the organizer. A number of participants of less than 10 or the impossibility to render contractual services due to force majeure will lead to cancellation. The organizer may cancel the course up to two weeks before its beginning. Participants will be informed without delay and the total sum of rendered payments will be refunded. Further claims cannot be asserted unless there is damage to physical integrity caused by negligence or malice on the part of the organizer. Travel expenses, hotel costs and/or other expenses will not be refunded in case of cancellation.

4.3. The organizer reserves the right to appoint substitute and additional lecturers as well as to modify the course schedule as long as essential contents of the course are not concerned and the modification is within an acceptable scope.

4.4. If certain lectures (meaning single lessons) cannot be held, participants are not entitled to claim an alternative date or the refund of course fees.

5. Conditions of payment

5.1. JurGrad gGmbH receives the summer course fees stated in the respective application forms. Fees do not include value added tax. JurGrad gGmbH is a nonprofit company exempt from turnover tax whose means serve the (advanced and postgraduate) education of the Westfälische Wilhelms-Universität Münster.

5.2. Fees are payable on receipt of invoice within the stated period.

5.3. Participants are obliged to pay the total sum of fee regardless of their course attendance, even if non-attendance is due to force majeure.

6. Withdrawal and non-attendance

In case of withdrawal from the application for the Summer Course the whole course fee becomes due.

7. Liability

JurGrad gGmbH assumes no liability for damages to person or material occurring during travel to or from the course location nor at the course location itself.

8. Confidentiality

8.1. Participants will be provided with the materials for the respective Summer Course without additional invoice.

8.2. Participants receive these copyright reserved materials as personal property and may not pass them on or make accessible to a third party.

8.3. Participants are obliged to treat all personal data of other participants or lecturers as strictly confidential.

9. Final Clauses

9.1 For the purpose of processing the registration, personal data stated in the registration form will be recorded, analyzed and forwarded to lecturers and other participants of the course in order to conclude a contract. Furthermore, JurGrad gGmbH would like to supply participants with information brochures in the future. Participants may object to the delivery of brochures at any time.

9.2. If any provision of these General Conditions of participation is found to be void, validity of the remaining provisions of this Agreement shall be unaffected. The void clause shall be substituted by an article that approximates in a legally recognized manner the economic objective of the provision to be replaced. In the case that these conditions of participation bear a gap, both parties will define or deem valid a provision corresponding to what they would have agreed upon taking the open aspect into consideration. Münster is the court of jurisdiction in case of juridical controversies arising from this contract agreement.
